INTRODUCTION

The Essential Law Library (ELL) flows from the Alberta Law Society Libraries' (ALSL) *Information Resources Policy* and defines the minimum level of ALSL collections considered essential to the practice of law in Alberta, to the provision of legal research and information services by the libraries, and to the retention of an archival collection of Canadian law in print. The ELL is comprised of four sections based on types of legal materials : Reference, Legislation, Law Reports and Texts.

The *ELL* was developed by a committee of ALSL public services librarians. In determining titles for inclusion, the committee used professional judgment in selecting those legal publications considered "best" in their subject areas. Each publication was evaluated based on its relevance or jurisdiction, currency, scope and uniqueness, reputation of the author, cost, ease of use and archival value. In addition, each publication had to meet the following criteria:

- best meet the quality criteria stated in the ALSL *Information Resources Policy*, s. 2
- be used frequently enough to justify inclusion
- provide coverage of major areas of law
- not be consolidations of legislation as these are available electronically and in the libraries (looseleaf publications which are largely consolidations of legislation were given particular scrutiny).

Essential resources for Regional and Local Libraries are restricted to areas of law practiced locally and provide for more than one subscription title per subject area only under special circumstances.

The development of *The Essential Law Library* ensures that the legal community and public in Alberta have guaranteed uniform access to a core collection of legal information resources and services at ALSL throughout the province. In addition, from a management perspective, the development of minimum collection standards allows ALSL to adopt a proactive approach to collection management, rather than a reactive one that responds to annual inflation rates and cancels subscriptions accordingly.

The Essential Law Library is intended to be a dynamic document, subject to continuous scrutiny, and amended as new editions of included texts are published or, in the professional opinion of staff, a more authoritative text on a particular subject than one currently included is published.

LIBRARY TYPES AND LOCATIONS

ALSL shall have a library in each Queen's Bench Judicial District.

The libraries in Calgary and Edmonton shall be designated **Resource Libraries** as they are both Court of Appeal and Queen's Bench centres, have local populations in excess of 750,000, and a practising bar of more than 1,000 members. Their collections will provide support and enrichment to Regional and Local Libraries.

The libraries in Lethbridge and Red Deer shall be designated **Regional Libraries** as they serve populations in excess of 100,000 and a practising bar of more than 100 members.

Libraries in Drumheller, Fort McMurray, Grande Prairie, Medicine Hat, Peace River, St. Paul and Wetaskiwin shall be designated **Local Libraries**. Their collections and services will vary depending on the size of the local population, the areas of law practised, and the size of the practising bar.
